More on Automated Clearing House (ACH)

Pegasus Bank is required to provide our clients, at least annually, a link to the National Automated Clearing House Association (NACHA) rulebook ("Rules"). The NACHA Rules govern the proper use of the ACH network and a new rulebook is published each January. For those of you who use our ACH service, you have agreed to comply with all applicable ACH rules in the creation and transmission of ACH transactions. You can learn more about the rules **here.**

For free access to a read-only copy of the NACHA Rulebook, please register on the NACHA website as a basic user at http://www.achrulesonline.org/. The Rulebook will help you answer any questions you may have regarding ACH transactions. The website will also provide you with updated rules and regulations as they become effective throughout the year. We also make information on all updates to the Rules available on our website under the ACH Origination section.

Of particular interest to Pegasus Bank ACH clients is a recent NACHA rule change that expanded the Same Day ACH processing window. Effective March 19, 2021, Pegasus Bank's cut-off time for Same Day ACH moved from 11 a.m. to 2:00 p.m. CT, allowing you more flexibility in originating ACH items.

NACHA members recently approved a measure to increase the per-payment maximum from the current \$100,000 to \$1 million, effective March 18, 2022. It will apply to all eligible Same Day ACH payments, including credits and debits for both businesses and consumers.
